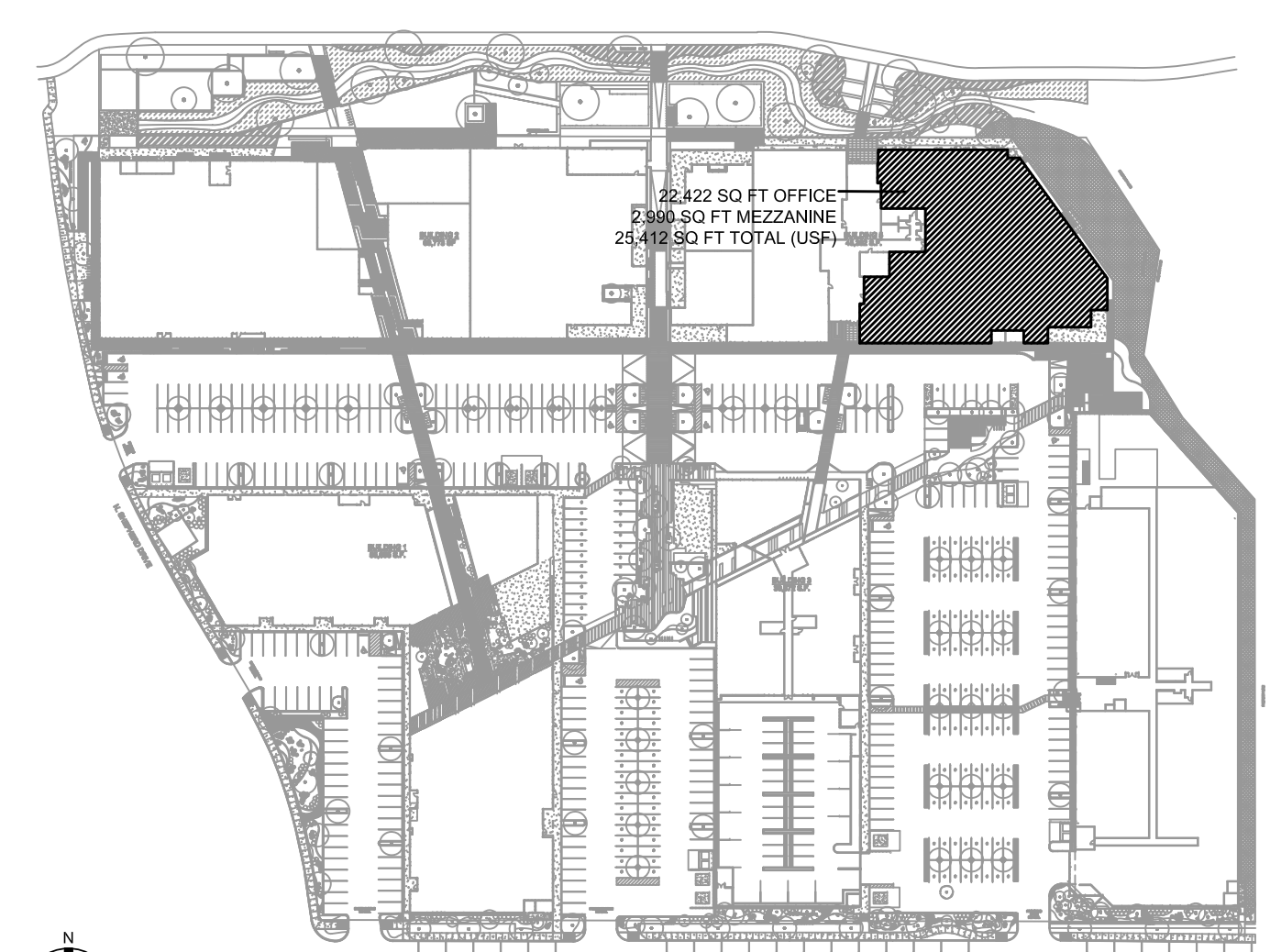

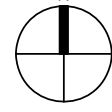
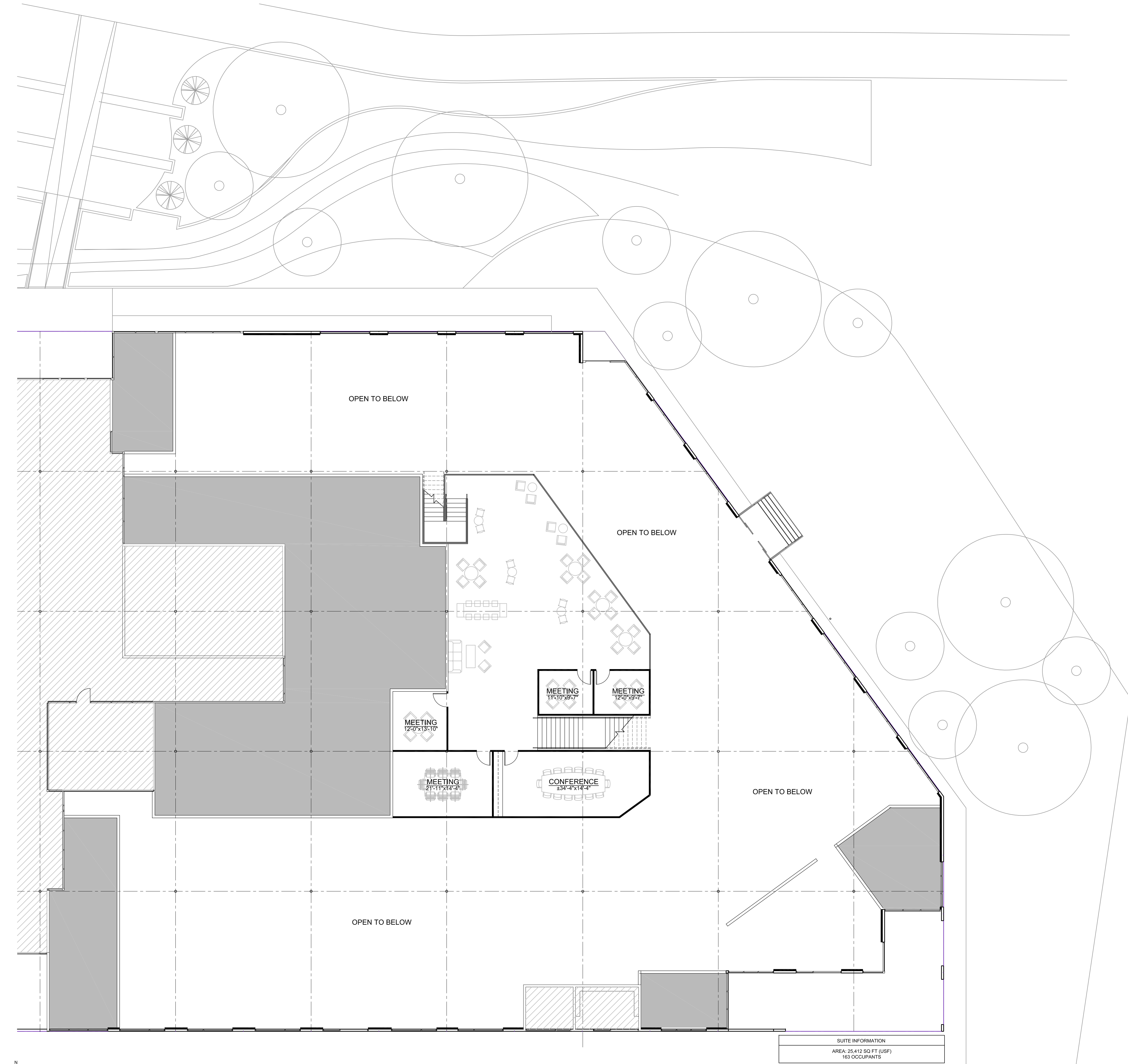


LOCATION PLAN 1

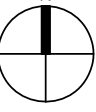
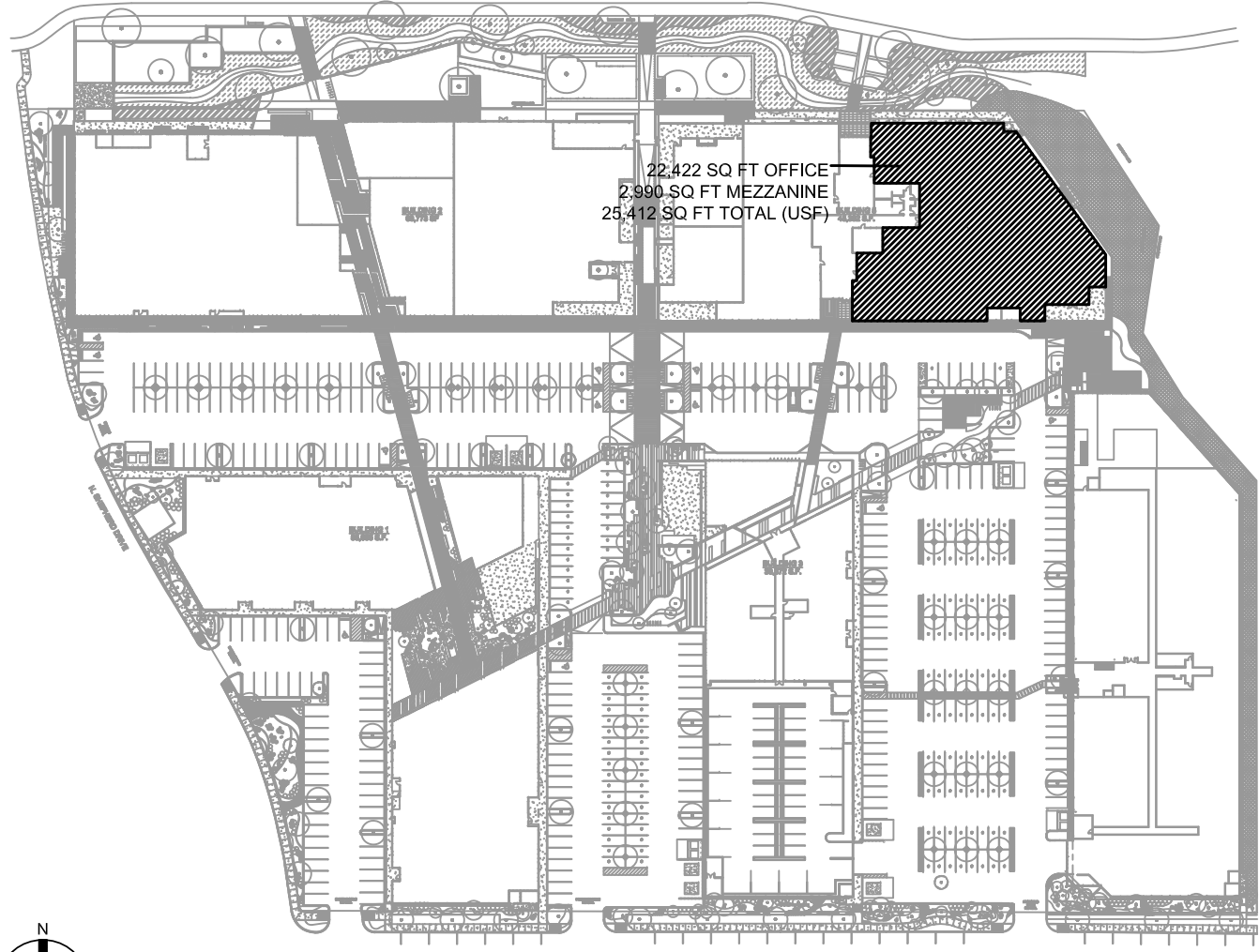
